- 4) Review of Golden Beet Awards and Fundraiser We had lots of people attend the Golden Beet Awards November 12. We raised enough money to cover the expenses of the event and raise about \$2000. For this year's fundraiser we are planning to host our event on a Thursday in September.
- 5) Financial Report: Review of Financial Audit and Tax Return
  Our financial audit and a draft of our 990 are completed. The draft has not changed except for
  the amounts of funding for each line item on page 2. We got a certified opinion in our audit that
  we are following good financial practices.
- 6) Committee Reports
  - a. Fund Development Committee
    Fund Development Committee met just before Christmas. We got an update on the
    grants that have been awarded and the ones still in process. We are under a match
    requirement, and we have to raise additional funds as unrestricted funds or grant
    funding. We were able to raise matching fund for the full amount of our requirement
    last year. One of the things we need to be able to demonstrate is how board members
    support the work. Council members can let staff or fund development committee
    members know about funding and sponsorship opportunities. Funders also want to
    know if board members personally support the organization, and it's important to be
    able to say that 100% of council members are contributing or securing in kind
    contributions. The fund development stresses the need for council members to make or
    secure contributions for our upcoming fundraising campaign. We just started using a
    new software program called Flipcause to help manage our fundraising campaigns.
    Discussion: are there specific things that we are always looking for, or does it come up
    for each event or campaign. Resources are not always viewed as dollars, they are

viewed as time commitments. There are also opportunities for each event. For example: donations of good or services needed to produce the summit.

Child Nutrition Reauthorization Senate Agriculture Committee submitted a bill late yesterday afternoon. Feeding America expects to strongly support the bill, it aligns with the goals that a coalition of organizations have advocated. It will be marked up tomorrow and it will be live streaming. It's expected to get strong support in the Senate, it is unsure about support in the House. Anti-Hunger advocates are encouraging the House to take up the Senate bill. Anne will send information tomorrow about advocacy for the bill and Kibibi will share it with council members. It would be a good idea to share your comments with Senator Stabenow Improving child nutrition Integrity act of 2016. CACFP, Summer Feeding, School Meals, WIC are included in the bill.
